Whereas appointment is strictly based on their merit for a period of one year extendable up to maximum of six year (One year at a time and subject to good performance and conduct) or till selection /promotion is made in accordance with the Rules of Recruitment governing these posts whichever is earlier. The appointees are directed to report to the Principal Govt. Medical College Jammu with in a period of 21 days from date of issuance of order.

The appointment in terms of SRO-24 of 2019 shall subject to the following conditions:

- The appointment under these rules shall not entitle the appointee to any preferential claim for regular appointment under normal process of selection / appointment.
- The appointment on academic arrangement under SRO-24 of 2019 shall terminate on the attainment of 65 years of age by the appointee.

- C. The service of these appointees shall be terminable before the expiry of the tenure of appointment with one month's notice from either side or payment of one month's salary in lieu of notice by appointing authority.
- D. The appointees shall have to execute an agreement with the Government on the prescribed form appended as Form 'A' to SRO - 24 of 2019.
- E. The appointees shall be paid monthly salary as per the scale provided in the SRO-24 i.e. pay equal to the revised basic pay which corresponds to the minimum of the pre-revised scale for the post as per SRO-193 dated 24-04-2018 and Dearness Allowance.
- F. The appointee shall not be entitled to any other additional monetary benefit what so ever except of house rent allowance as applicable to in service candidates carrying minimum of the pre-revised scale of the post subject to fulfillment of the conditions provided under the relevant rules in this regard.
- G. In matters of discipline and conduct the appointee shall be governed by rules, regulations and orders in vogue in the UT Civil services on the subject.
- H. Any residuary matter shall be governed by the SRO-24 of 2019.
- I. The appointee shall be allowed to join on production of certificates and testimonials in original.
- J. The appointee are directed to report to the Principal, Govt. Medical College, Jammu within 21 days of the issuance of this order failing which their selection shall be deemed to have been cancelled.
