Whereas, Jammu and Kashmir Service Selection Board advertised 02 posts of Junior Staff Nurse (Division Cadre Jammu) vide advertisement No. 05 of 2015 (Item No. 264);

Whereas, while the selection against the posts was under process, certain candidates were engaged as Sr. Staff Nurse/Jr. Staff Nurse/FMPHW on academic arrangement basis under SRO-384 of 2009, to overcome the shortage of man power in the hospitals;

Whereas, few of the above mentioned candidates engaged as Sr. Staff Nurse/Jr. Staff Nurse/FMPHW on academic arrangement basis under SRO-384 of 2009 approached the Hon'ble Court and filed a Writ Petition, SWP No. 2532/2016 titled "Nancy Kumari Bhat & Others" seeking relief for their permanent appointment against these posts. Wherein the Hon'ble High Court passed the interim directions reproduced as under:

"Status Quo shall be maintained. It is made clear that in case the official respondents continue with the selection process, the same would not be finalized without the permission of the Court and would be subject to the outcome of the Writ Petition" on dated: 01-12-2016";

Whereas, the select list of two candidates for the posts of "Jr. Staff Nurse" was finalized and issued by JKSSB vide Letter No: SSB/Sel/Secy/2017/1780, dated: 06-02-2017, which was endorsed to this office by the Administrative Department i.e. H&ME vide letter No. ME/NG/229/2016 dated: 15-03-2017.

Whereas, later on the Hon'ble Court in SWP No. 2512/2015, MP Nos. 5/2017, 3/2016, 1/2015, 4/2017, 3/2017 titled Abhishek Sharma & Ors. Vs. State & Ors. c/w SWP No. 2532/2016, MP Nos. 5/2017, 4/2017, 7/2017, 9/2017 and SWP No. 3131/2015, MP No. 1/2015 titled Nancy Kumari Bhat & Ors. Vs. State & Ors. and Naresh Kumari & Ors Vs. State & Ors. passed order on 04-05-2018 which reproduced as:
