The said applications are available in the prescribed form from the office of the undersigned on production of **Bank Draft of Rs. 500/- (Rupees five hundred) only pledged to Principal Govt. Medical College, Jammu from J&K Bank only . This is without any prejudice to any writ petition lying pending before any Hon'ble Court of law:-**

1. CONDITIONS AND ELIGIBILITY:-

Incomplete application form(s) in any aspect or incomplete relevant documents submitted shall invite rejection without further communication.

FOR IN-SERVICE (PSC)/CANDIDATES:-

a.) For PSC Candidates:-

- 1) The in-service doctor shall be paid salary as per their LFC.
- 2) The in-service doctor shall be allowed to participate in the selection process only with the prior permission of the Administrative Department as per circular No. 02-JK (HME) of 2020 dated 20-01-2020 read with Govt. order No. 03-HME of 2019 dated 27-05-2019 For the purpose, they should route their application forms through the Administrative Department. **No advance copy shall be entertained.**
- 3) In case of selection, they will be allowed to join only after getting relieved from their Administrative Department.

b.) FOR CANDIDATES WHO ARE NOT IN GOVT. SERVICE :- (Non PSC Candidates)

1. The Non-PSC doctors shall be engaged on consolidated pay equal to basic pay for the post of Assistant Surgeon in the Health Department as per SRO-93 dated 15-04-2009 plus dearness allowance. Maximum age for eligibility to apply shall be 50 years as on cut off date.

c.) GENERAL CONDITIONS OF ELTGIBILITY FOR ALL CANDIDATES:-

1. **QUALIFICATIONS** - Minimum MBBS. (MD, MS will be preferred).
2. **The doctors who were earlier appointed as Registrar/Demonstrator in any institution / Govt. Medical College, Jammu but had left services before completing their tenure need not apply.**
3. **The doctors who have already completed 3 years as Registrar /Demonstrator in any discipline need not apply and their application forms shall not be entertained.**
4. Any appointee(Doctor) intending to leave the job shall have to provide one month prior notice duly forwarded by the concerned HoD or else the doctor shall have to deposited one month's salary in this institution.



d.) THE APPLICATION FORM SHOULD BE ACCOMPANIED WITH ATTESTED COPIES OF THE FOLLOWING DOCUMENTS/TESTIMONIALS:-

1. Attempt Certificate of 1st, 2nd, Pre-final and Final MBBS examinations issued by the concerned Universities.
2. MBBS, MD/MS Degree/Diploma in the concerned subject.
3. Internship completion certificate.
4. Service Certificate (clearly indicating Rural Service if any) issued by the Director, Health Service, Jammu /Srinagar in respect of in-service doctors.
5. Distinction/National Scholarship/Honours/Medals/Academic Merit Certificate.
6. House Job Certificate (Jr. /Sr.) issued by the concerned Principal or equivalent recognized authority.
7. Professional Publications in a MCI permitted indexed standard Medical Journals, if any.
8. Date of Birth as per matriculation certificate (for Non PSC candidates).
9. Affidavit duly attested by the 1st Class Magistrate declaring:-
 - a) That the applicant has not done / doing Registrar-ship / Demonstrator-ship/ Sr. Resident ship inside or outside the U.T. J&K.
 - B) The applicant is not pursuing Registrar-ship/ Demonstrator-ship/ Sr. Resident in any of the newly establish ed Govt. Medical Colleges in U.T of Jammu and Kashmir
10. PRC/ Domicile Certificate.
11. NoC from Administrative Department Health and Medical Education in case of in service candidate.
12. PSC Candidates if selected will be permitted to join after furnishing relieving from Administrative Department.

The selection of the candidates will be made on the basis of combined academic merit and performance in the interview. No TA/DA will be admissible for appearing in interview .
