2. Application as per prescribed format should reach to the office of Personnel Officer, Associated Hospitals, GMC Jammu by Registered post/Speed Post by or before 18.03.2021 ; no form will be entertained after last date of receipt of forms.
3. List of document to be attached with the application form:
 - i. Copy of Date of Birth Certificate;
 - ii. Copy of Permanent Residence Certificate/Domicile Certificate;
 - iii. Copy of Degree/ Diploma from the recognized University/ Institute for the required qualification as per the post applied for;
 - iv. Copy of Marks sheet of all semesters/ one consolidated marks sheet indicating marks of all the semesters of the required qualification for the post applied for;
4. The candidates who have obtained degrees through Distance Education Mode from the Universities recognized by the UGC as mentioned in Govt. Order No. 252-HE of 2012 dated: 30-05-2012 issued by the Higher Education Department Civil Secretariat, J&K after 2005 shall have to submit a certificate from the concerned university along with application form stating that candidate had undergone the degree from their University head-quarters and not from the off-campus which have been established by these Universities beyond their territorial jurisdiction. Application shall not be accepted in absence of this certificate.

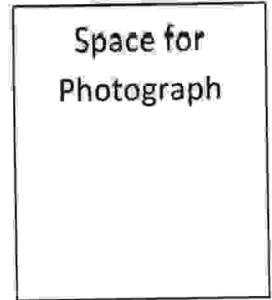
