Whereas applications were invited from eligible candidates for the post of Anesthesia Assistant under SRO-24 dated 10-01-2019 in GMC & Its Associated Hospitals Jammu, UT of J&K; vide advertisement notice No. 06 of 2020 dated 18-09-2020;

Whereas following criteria had been adopted for the preparation of the merit;

i. Prescribed Basic Qualification	60 points
ii. Technical Qualification	40 points
iii. Total Points	100 points

Now, in view of above and as recommended by the selection committee constituted in terms of SRO-24, dated 10-01-2019; sanction is hereby accorded to the appointment of the candidates as per annexure "A" against the post of Anesthesia Assistant.

The selection is subject to genuineness of all academic/technical certificate viz a viz recognition of institute.

The appointee shall report to the office of the Principal, Govt. Medical College, Jammu within a period of 21 days from the date of issuance of this order.

In case, the appointee fails to join the Department within stipulated period of time, his appointment shall be deemed to have been cancelled without any further notice. The appointee shall be allowed to join only on the production of the following documents/ certificates in original.


- Academic/Technical Qualification Certificate.
- Date of birth Certificate.
- Health Certificate from the concerned Chief Medical Officer of the District.
- Domicile Certificate issued by competent Authority.
- Certificate from the concerned District Industries Centre (DIC) and the District Employment and Counseling Centre to the effect that no loan under self employment scheme has been taken by the appointee.
- Relevant Category Certificate.
- Character Certificate from the concerned Police station.
- An appointee shall have to execute an agreement stating that he/she will not take part in any kind of political activity and strikes.

The appointment is strictly governed by the following terms and conditions of SRO-24:

- The appointment shall be on academic arrangement basis initially for a period of one year extendable upto maximum of six years (one year at a time and subject to good

- performance and conduct) or till the selection/promotion is made in accordance with the rules of Recruitment governing these posts, whichever is earlier.
2. The Appointment on academic arrangement basis shall by itself stand terminated on the attainment of 65 years of age by the appointee.
 3. The services of these candidates shall be terminable before the expiry of the tenure of appointment with one month's notice by appointing authority.
 4. The appointees shall have to execute an agreement with the Government on the prescribed form appended as Form "A" to SRO-24 of 2019.
 5. The appointees shall be paid consolidated pay equal to the revised basic pay which corresponds to the minimum of the pre-revised scale for the post as per SRO-193 dated 24-04-2018 + dearness allowance.
 6. The appointees shall not be entitled to any other additional monetary benefit, what so ever except of House Rent Allowance as applicable to in-service candidate carrying minimum of the pre-revised scale of the post subject to fulfillment of the conditions provided under the relevant rules in this regard.
 7. In matter of discipline and conduct, the selected candidate shall be governed by the rules, regulations and orders in vogue in the Civil Services Rules on the subject.
 8. Any residuary matter shall be governed by the SRO-24 dated 10-01-2019.

The order is issued subject to the outcome of any writ petition(s) pending in any court of law of the competent jurisdiction.
