Subject: Appointment of "FMPHW" in the pay scale of (5200-20200+1900) "Health & Medical Education Department", Divisional Cadre Jammu, in pursuance to JKSSB Advertisement Notification No. 05 of 2015 under Item No. 267.

Whereas against the posts of FMPHW referred to Service Selection Board, Service Selection Board advertised 53 posts of FMPHW vide advertisement No. 05 of 2015 (Item No. 267);

Whereas the selection list for the Post of FMPHW was finalized and issued by SSB vide No: SSB/Sel/Secy/2016/14070-76, dated: 19-05-2016 in reference to Advertisement No: 05 of 2015 under Item No. 267 which was endorsed to this office by Administrative Department vide No. ME/NG/115/2016-partfile dated: 27-06-2016;

Whereas, the Hon'ble Court vide Order dated: 23-05-2017 in MP No: 03/2016, 06/2017 & 08/2017 has modified the Interim directions dated: 01-12-2016 and passed orders reproduced as under;

"Since the process of selection is complete, the private respondents, who have already been selected, shall be allowed to join on the post of FMPHW. It is made clear that joining of private respondents on the post in question shall not create any equity in their favour and shall be remain subject to the outcome of the writ petition".

Whereas, after perusing the select list, it was observed that recommendation in case of Shoba Rani 02/OM, Narinder Kour 03/OM, Kamlesh Kumari 05/OM, Yasmeen Akhter 06/OM, Anu Radha 20/OM/SC, Surishta Sharma 21/OM/RBA, Mandeep Kour 22/OM, Jiwani Jyoti 25/OM, Sheenam Kerni 26/OM, Nisha Kumari 28/OM, Malti Sharma 30/OM, Pooja Rani 31/OM, Amarjeet Kour 32/OM, Tasveer Akhter 33/OM, Lovely Reena 34/OM/RBA, Arti Pagotra 35/OM/SC, Suman Kumari 36/OM/SC, Anu Nathial 39/OM, Monika Kumari 41/OM, Arshu Rani 42/OM, Suman Sharma 43/OM/HCL, Sweety Kotwal 1/RBA, Nazia Kousar 02/RBA, Radha Devi 03/RBA, Kaushalya Devi 04/RBA, Rita Devi 05/RBA, Farzana Koser 01/ST, Shahida Banoo 02/ST, Nisha Choudhary 01/ALC was withheld for want of fulfillment of certain deficiencies. The recommendation withheld was released later on by above references no. of SSB.

Whereas, Appointment order was issued in favour of 51 no. of candidates, out of which 43 candidates joined this office in pursuance to appointment order issued by this office vide no. 59/AHJ of 2018 Dated: 21-05-2018;

Whereas, a final notice was issued under endorsement no. AHJ/FMPHW/2018/3998-4003 Dated: 30-11-2018 to remaining 08 Candidates for joining, but they failed to join within the stipulated time period failing which the candidature of the selected candidates as FMPHW was cancelled;

Whereas, this office sought the permission of Administrative Department to operate waiting list vide letter no. AHJ/M.Sc trg.-24/2018/57 Dated: 04-01-2019 and Administrative Department vide letter no. ME/NG/115/2016 Dated; 23-04-2019, granted the permission to operate waiting list;

Whereas, in compliance to Administrative Department letter no ME/NG/115/2016 Dated: 23-04-2019 sanction was accorded to the appointment of candidates as FMPHW, from waiting list of Open Merit, in Govt. Medical College & Associated Hospitals, Jammu (Division Cadre Jammu) in the pay scale of 5200-20200+1900 whose recommendations were clear;

Whereas, in response to Administrative Department's letter no. ME/NG/115/2016 Dated: 10-03-2020, status of the post of FMPHW was submitted vide this office letter no. AHJ/N/S/2020/2614 Dated; 04-06-2020;

Whereas, JKSSB vide letter no. SSB/Sel/Secy/2016/15/177-79 dated 14-01-2020 has conveyed that recommendation of the below mentioned candidate has been cleared and Administrative Department vide letter no. ME-NG-115/2016 dated 03-07-2020 has granted approval to operate waiting list of the concerned candidate and issue appointment order in her favour;

Now, therefore sanction is hereby accorded to the appointment of below mentioned candidate as FMPHW, from waiting list of Open Merit, in Govt. Medical College & Associated Hospitals, Jammu (Division Cadre Jammu) in the pay scale of 5200-20200+1900.

The appointee shall report to the Office of the Principal, Govt. Medical College, Jammu within a period of 21 days from the date of issuance of this Order. In case, the appointee fails to join the Department within the stipulated period of time, her appointment shall be deemed to have been cancelled without any further notice.

The appointment including pay, service etc shall be governed as per the provision of S.O. 194 dated: 17-06-2020 and the appointee shall be on probation for a period of two years in terms of this notification.

The appointee shall be allowed to join only on the production of the following documents/certificates in original:

1. Academic/ Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Permanent Resident Certificate.
5. No Loan Certificate from the concerned District Industries Centre (DIC) and the District Employment and Counselling Department to the effect that no loan under self employment scheme has been taken by the appointee.
6. Relevant Category Certificate (if any).
7. Character Certificate from the concerned Police Station.




The appointment is subject to the following conditions:-

1. The appointee shall give an undertaking in the shape of an affidavit attested by 1st Class magistrate to the effect that in case, adverse report about his character and antecedents is received from the Inspector General of Police, CID J&K to whom a reference shall be made by the concerned, the candidate shall have no right to claim his/her appointment as FMPHW and his/her appointment shall stand automatically deemed to have been cancelled ab-initio.
2. If on verification, the certificates produced by the appointee proved to be fake or forged, the appointment shall stand as cancelled ab-initio.
3. The interim arrangement, if any, made against the above posts on academic arrangement basis or on deputation basis shall be deemed to have been terminated forthwith.
4. The salary of the appointee shall be disbursed only on receipt of the verification report with regard to her character & antecedents and verification of documents and testimonials i.e Academic, Technical and Category from the verifying agency.
5. The appointment of the said candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated: 24-12-2009.
6. The inter-se-seniority of the appointee(s) shall be in order of merit furnished by J&K Service Selection Board which shall be notified separately.
7. The appointment in Divisional Cadre is not transferable from one Division to another and change of Cadre is not acceptable.
