As per the recommendation released by JKSSB vide Letter No. SSB/Secy/Sel/2018/1929-35 dated: 19-02-2018 and further approval conveyed by the Administrative Department vide letter No. MD/NG/36/2014 dated: 12-04-2018, sanction is hereby accorded to the appointment of **Smt. Sudesha Devi** D/o Sh. Jittam Singh W/o Sh. Shash Pal Singh R/o Haddal, Bhadarwah, Doda under ST category as **Junior Assistant** in the **pay scale of 5200-20200 with grade pay 1900** in Government Medical College & Associated Hospitals, Jammu.

The appointment of the candidates shall subject to fulfilment of the following conditions:-

- A. The appointee shall report to the Principal, Govt. Medical College, Jammu within a period of 21 days from the date of issuance of this Order.
- B. In case, the appointee fails to join the Department within the stipulated period of time, his/her appointment shall be deemed to have been cancelled without any further notice.
- C. The appointee shall be allowed to join only on the production of the following documents/certificates in original:-
 - i. Academic/ Technical Qualification Certificate.
 - ii. Matriculation/ Date of birth Certificate.
 - iii. Health Certificate from the concerned Chief Medical Officer of the District.
 - iv. Permanent Resident Certificate issued by the competent Authority.
 - v. Certificate from the concerned District Industries Centre (DIC) and the District Employment and Counselling Centre to the effect that no loan under self employment scheme has been taken by the appointee.
 - vi. Relevant Category Certificate (if any).
 - vii. Character Certificate from the concerned Police Station.
- D. The appointment of the candidate as Junior Assistant shall further be subject to the following conditions:-
 - i. The appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about his/her character and Antecedents is received from the Inspector General of Police, (CID) J&K to whom a reference shall be made by the concerned, the candidate shall have no right to claim his/her appointment as Junior Assistant and his/her appointment as such shall be deemed to have been cancelled ab-initio.
 - ii. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
