Whereas against 110 posts of Sr. Staff Nurse referred to Service Selection Board, Service Selection Board advertised 84 posts of Senior Staff Nurse vide advertisement No. 04 of 2015 (Item No. 099);

Whereas while the posts were referred, certain Sr. Staff Nurse/Jr. Staff Nurse were engaged on academic arrangement under SRO-384 including Nancy Kumari Bhat, to overcome the shortage of man power;

Whereas after the engagement of these nurses under SRO-384 of 2009 a Writ Petition, SWP No. 2532/2016 titled "Nancy Kumari Bhat & Others" was filed in the Hon'ble High Court. The Hon'ble High Court passed interim Order reproduced as under:

**"Status Quo shall be maintained. It is made clear that in case the official respondents continue with the selection process, the same would not be finalized without the permission of the Court and would be subject to the outcome of the Writ Petition" on dated: 01-12-2016";**

Whereas the select list for the Post of Sr. Staff Nurse was finalized and issued by SSB vide No: SSB/Sel/Secy/2016/21536-42, dated: 29-12-2016 in reference to Advertisement No: 04 of 2015 under Item No. 099 which was endorsed to this office by Administrative Department vide No. ME/NG/44/2012-partfile dated: 08-02-2017;

Whereas, some of candidates who got selected through SSB as Sr. Staff Nurse were arrayed as Private respondents in SWP 2532/2016 through MP No. 03/2017

Whereas, the Hon'ble Court vide Order dated: 23-05-2017 in MP No: 03/2016 has modified the interim directions dated: 01-12-2016 and passed orders reproduced as under;

**"Since the process of selection is complete, the private respondents, who have already been selected, shall be allowed to join on the post of Senior Staff Nurse. It is made clear that joining of private respondents on the post in question shall not create any equity in their favour and shall be remain subject to the outcome of the writ petition".**

Whereas, after perusing the select list, it was observed that recommendation in case of Raksha Mahajan 12/OM and Vishal Arora 24/OM was withheld for want of fulfillment of certian deficiencies. The recommendation withheld was released later on by
