Sub:- Installation of Minipool PCR based NAT Testing on Reagent rental Basis.

Govt. Medical College Jammu intends to install Minipool PCR based NAT Testing System on Reagent Rental Basis in the Department of Blood Transfusion Medicine, GMC Jammu. For the purpose and in order get the best system installed in the Department, Expression of interest is hereby called from the Original manufacturers or the bidders having authorization from the Principal Manufacturers to install the above mentioned system on the following terms & Conditions:-

1. The EoI should reach the office of the undersigned latest by **10-12-2019**.
2. Placement of the system shall be free of charges.
3. Rates of the reagents shall be fixed for a period of 5 years from the date of successful installation and thereafter shall be reviewed for further extension of 5 years.
4. The successful bidder shall have to maintain the equipments placed on RRB free of charges during the contractual period.
5. The intending bidders have to produce the following documents:-
 - i. GST Registration No.
 - ii. Drug Sales License of bidder.
 - iii. Drugs manufacturing license of Manufacturer / Indian Subsidiary.
 - iv. Non conviction certificate of the bidder as well as Manufacturer/ Indian Subsidiary.
 - v. IEC Code of the importer.
 - vi. List of installation in the country supported with order copies.
 - vii. The system to be installed should be USFDA, DCGI and IVD approved. Necessary documents in this regard shall have to be attached.
 - viii. Turnover certificate issued by the Chartered Account having annual Turnover of more than 15.00 crores per year for the last three years.
6. Work load = 2500 (approx) per month.
