Whereas against 441 posts of Jr. Staff Nurse referred to Service Selection Board, Service Selection Board advertised 161 posts of Junior Staff Nurse vide advertisement No. 03 of 2014 (Item No. 289);

Whereas as while the posts were referred, some Jr. Staff Nurse were engaged on academic arrangement under SRO-384 including Nancy Kumari Bhat, to overcome the shortage of man power;

Whereas after her engagement in year 2016, Nancy Kumari Bhat & Others filed a Writ Petition, SWP No. 2532/2016 in Hon'ble High Court whereunder interim Order was passed reproduced as under:

"Status Quo shall be maintained. It is made clear that in case the official respondents continue with the selection process, the same would not be finalized without the permission of the Court and would be subject to the outcome of the Writ Petition" on dated: 01-12-2016;

Whereas the select list for the Post of Jr. Staff Nurse was finalized and issued by SSB vide No: SSB/Secy/Sel/2016/2016/20287-93 dated: 18-11-2016 in reference to Advertisement No: 03 of 2014 under Item No. 289 which was endorsed to this office by Administrative Department vide No. ME/NG/44/2012 dated: 13-02-2017;

Whereas in the meantime some candidates who were selected by SSB against the post of Jr. Staff Nurse also approached Hon'ble High Court through SWP No: 3006/2017, titled "Ruksana Banoo & Ors. V/s State & Others" & "SWP No.: 1454/2017, MP No. 01/2017 titled Pooja Sumberia v/s State & Ors in which Hon'ble High Court has passed the orders directing Respondent No. 02 i.e Principal, Govt. Medical College, Jammu to consider the recommendations made by SSRB in favour of the petitioners for appointment to the post of Jr. Staff Nurse, Divisional Cadre, Jammu against reserved category in accordance with the rules and regulations applicable by passing a speaking order within a period of one month from the date of receipt of copy of the writ petition;

Whereas the matter was considered and it was felt that large No. of posts of Jr. Staff Nurse are vacant & it has become difficult to carry on day to day working of the Hospital, in view of which it was decided that Writ petitioners of SWP 2532/2016 titled "Nancy Kumari & Others v/s State & Others" may continue in view of court direction dated: 01-12-2016 till the disposal of said writ petition & simultaneously also appoint petitioners of petition No. 3006/2017 and 1454/2017, who have been selected against different set of vacancies of Jr. Staff by SSB;
