- C. In case, the appointee fails to join the department within the stipulated period of time, his/her appointment shall be deemed to have been cancelled without any further notice.

 - d. Permanent Resident Certificate issued by the competent Authority.
 - e. Certificates from the concerned District Industries Centre (DIC) and the District Employment and Counselling Centre to the effect that no loan under self employment scheme has been taken by the appointee.
 - f. Relevant Category Certificate, in case belonging to the reserved category.
- E. The appointment of the candidates as Junior Assistant shall further be subject to the following conditions:-
