The appointee shall be allowed to join only on the production of the following documents/ certificates in original.

- Date of birth Certificate.
- Health Certificate from the concerned Chief Medical Officer of the District.
- Domicile Certificate issued by competent Authority.
- Character Certificate from the concerned Police station.
- An appointee shall have to execute an agreement stating that he/she will not take part in any kind of political activity and strikes.

4/The selection of the candidate will be purely on contractual basis. In case of poor performance, services of the candidates are liable to be terminated without any prior notice.
