1. CONDITIONS AND ELIGIBILITY:-

Incomplete application form(s) in any aspect or incomplete relevant documents submitted shall invite rejection without further communication.

2. IN-SERVICE (PSC)/CANDIDATES:-

a.) For PSC Candidates:-

- 1) The in-service doctor shall be paid salary as per their LPC.
- 2) The in-service doctor shall be allowed to participate in the selection process only with the prior permission of the Administrative Department as per circular no. 02-2K (HME) of 2020 dated 26-01-2020 read with Govt. order No. 03-HME of 2019 dated 27-05-2019. For the purpose, they should submit their application forms through the Administrative Department. No advance copy shall be entertained.
- 3) In case of selection, they will be allowed to join only after getting relieved from their Administrative Department.

b.) FOR CANDIDATES WHO ARE NOT IN GOVT. SERVICE :- (Non PSC Candidates)

- 1) The Non-PSC doctors shall be engaged on consolidated pay equal to basic pay for the post of Assistant Surgeon in the Health Department as per SRO-23 dated 15-04-2008 plus dearness allowance. Maximum age for eligibility to apply shall be 50 years as on cut off date.

3. GENERAL CONDITIONS OF ELIGIBILITY FOR ALL CANDIDATES:-

1. QUALIFICATION:- Minimum MBBS, (MD) MS will be preferred.
2. The doctors who were earlier appointed as Registrar/Demonstrator in any Institution / Govt. Medical College, Jammu but had left services before completing their tenure need not apply.
3. The doctors who have already completed 3 years as Registrar / Demonstrator in any discipline need not apply and their application forms shall not be entertained.
4. Any candidate (Doctor) intending to leave the job shall have to provide one month prior notice duly provided by the concerned MD or else the doctor shall have to deposited one month's salary in this institution.

7. Professional Publications in a MCI permitted indexed standard Medical Journals, if any.
8. Date of Birth as per matriculation certificate (for Non PSC candidates.)

 - a) That the applicant has not done/ doing Registrar-ship/Demonstrator-ship /Sr. Resident-ship inside or outside the of U.T. J&K
 - b) The applicant is not pursuing Registrar-ship/ Demonstrator-ship/ Sr Residents-ship in any of the newly established Govt. Medical Colleges in U.T of Jammu and Kashmir.
