- The successful quotationer shall have to execute the supply at the earliest from the date of issuance of formal Order with them being a matter of urgent local purchase due to non-availability of said drugs/narcotics on GEM Portal and also due to non-supply of said drugs/narcotics from JKMSCL / M/S Amrit Pharmacy.
- The quoter has to submit the name of company/manufacturer on the quotation of the drugs/narcotics to be supplied alongwith the authority letter of being the authorized dealer of the manufacturer/company.
- The Analytical report of the drugs/narcotics should be attached with the supply and the shelf life of the drugs/narcotics should be atleast one year or $\frac{3}{4}$ of life whichever is more.
- If the Supplier failed to supply at the quoted rates, then the undersigned reserves the right for debarring/blacklisting of firm for a period not less than 2 years.
- The undersigned reserves the right to accept or reject any quotation or a part thereof, without any reason. Any dispute, if arises, shall be subject to the Jammu jurisdiction.
