Whereas, to strengthen COVID-19 testing capacity during the prevailing crisis of COVID-19 pandemic, sanction was accorded by MD, National Health Mission, J&K vide No.SHS/NHS/J&K/810-816 dated 19/04/2021 read with SHS/NHM/J&K/DNO-J/3496-3501 dated 15-06-2020, subsequently a Walk-in-Interview was held on 11/05/2021 vide advertisement notice No. GMC/COVID-19/2021/52 dated 29/04/2021 for the below mentioned posts in the Department of Microbiology, GMC, Jammu for a tenure of three months extendable upto 6 (six) months under Emergency Response and Health System preparedness package (ECRP) purely on contract basis on monthly remuneration as mentioned against below:-

1. The monthly remuneration shall be paid only after the submission of undertaking regarding the genuineness of documents from the competent authority and if any adverse remarks are received, the selection shall be cancelled without any notice.
2. The appointee shall be purely on contract basis on the fixed remuneration settled by the appointing authority based on his/her experience and qualification.
3. The appointment shall not confer any right to the appointee to claim for regularization and his/her term shall be deemed to be ceased after the completion of specified period.
4. The appointee shall be responsible for the job assigned by the competent authority from time to time.
5. The candidate has to submit an undertaking accepting all the terms and conditions therein.
6. The waiting list shall remain operational for one month only.
7. The candidate has also to submit the undertaking regarding the genuineness of his/her documents submitted to this office.
8. The appointment shall be subject to work and conduct of the selected candidate in the Institution remaining satisfactory during the period. In case of any misconduct or negligence in duties or found indulging in strike or any other activities which affect the department services, the appointment or the candidate shall be terminated without any notice.
