Whereas applications were invited from eligible candidates for the post of Paramedics/Nurses under SRO-24 dated 10-01-2019 in GMC & Its Associated Hospitals Jammu, UT of J&K; vide advertisement notice No. 06 of 2020 dated 18-09-2020;

Whereas following criteria has been adopted for the preparation of the merit:

1. For the posts at S.No. 1,3,4,6,8, 10 and 11 of the advertisement notice no. 06 of 2020 dated 18-09-2020
  - (i) Prescribed Basic Qualification 60 points
  - (ii) Technical Qualification 40 points
  - (iii) Total Points 100 points
2. For the posts at S.No.5,7,9,12 of the advertisement notice no. 06 of 2020 dated 18-09-2020; the weightage was as per merit achieved in prescribed technical qualification.

Now, In view of above and as recommended by the selection committee constituted in terms of SRO-24, dated 10-01-2019; sanction is hereby accorded to the selection list of the candidates against the various nurses and paramedics posts; (As per Annexure- A)) with the order.

### **The Selection is strictly governed by the following terms and conditions of SRO-24:**

- a. The selection shall be on academic arrangement basis initially for a period of one year extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till the selection/promotion is made in accordance with the rules of Recruitment governing these posts, whichever is earlier.
- b. The selection on academic arrangement basis shall by itself stand terminated on the attainment of 65 years of age by the appointee.
- c. The services of these selected candidates shall be terminable before the expiry of the tenure of appointment with one month's notice by appointing authority.

- d. The selected candidate shall have to execute an agreement with the Government on the prescribed form appended as Form "A" to SRO-24 of 2019.
- e. The selected candidate shall be paid consolidated pay equal to the revised basic pay which corresponds to the minimum of the pre-revised scale for the post as per SRO-193 dated 24-04-2018 + dearness allowance.
- f. The selected candidate shall not be entitled to any other additional monetary benefit, what so ever except of House Rent Allowance as applicable to in-service candidate carrying minimum of the pre-revised scale of the post subject to fulfillment of the conditions provided under the relevant rules in this regard.
- g. In matter of discipline and conduct, the selected candidate shall be governed by the rules, regulations and orders in vogue in the Civil Services Rules on the subject.
- h. Any residuary matter shall be governed by the SRO-24 dated 10-01-2019.
- i. The selected candidates are directed to report to the Principal, Govt. Medical College Jammu within 10 days of the issuance of this order failing which their selection shall be deemed to have been cancelled.
- j. The selected candidates shall be allowed to join on production of certificates and testimonials in original.
