Whereas the selection list of nurses and Paramedics was issued vide order no. 589/AHJ of 2020 dated 02-12-2020 under SRO-24 of 2019 pursuant to advertisement no. 06 of 2020 dated 18-09-2020 wherein 15 candidates for the post of Sr. Staff Nurses were selected.

Whereas selected candidates were directed to join within 10 days in the office of the Principal, Govt. Medical College, Jammu from the date of issuance of the order failing which their appointment was deemed to have been cancelled without any further notice.

Whereas 01 vacancy under ALC category has been created due to the non-joining of the candidate selected under ALC category vide order no. 589/AHJ of 2020 dated 02-12-2020.

The appointment is strictly governed by the following terms and conditions of SRO-24:

- The appointment shall be on academic arrangement basis initially for a period
 of one year extendable upto maximum of six years (one year at a time and
 subject to good performance and conduct) or till the selection/promotion is
 made in accordance with the rules of Recruitment governing these posts,
 whichever is earlier.
- 2. The Appointment on academic arrangement basis shall by itself stand terminated on the attainment of 65 years of age by the appointee.
- 3. The services of the candidate shall be terminable before the expiry of the tenure of appointment with one month's notice by appointing authority.
- 4. The appointee shall have to execute an agreement with the Government on the prescribed form appended as Form "A" to SRO-24 of 2019.
- The appointee shall be paid consolidated pay equal to the revised basic pay which corresponds to the minimum of the pre-revised scale for the post as per SRO-193 dated 24-04-2018 + dearness allowance.
- 6. The appointee shall not be entitled to any other additional monetary benefit, what so ever except of House Rent Allowance as applicable to in-service candidate carrying minimum of the pre-revised scale of the post subject to fulfillment of the conditions provided under the relevant rules in this regard.

- 7. In matter of discipline and conduct, the selected candidate shall be governed by the rules, regulations and orders in vogue in the Civil Services Rules on the subject.
- 8. Any residuary matter shall be governed by the \$R0-24 dated 10-01-2019.
- i. The selected candidate is directed to report to the Priincipal, Govt. Medical College Jammu within 10 days of the issuance of this order failing which their selection shall be deemed to have been cancelled.
- ii. The selected candidates shall be allowed to join on production of certificates and testimonials in original.

The order is issued subject to the outcome of any writ petition(s) pending in any court of law of the competent jurisdiction.
