Subject:- Un-authorized absence from duty-show cause notice regarding.


Whereas, you were appointed vide order no:-198 AHJ of 2014 dated:-26.09.2014 under endorsement no:- 2422-26 dated:- 26.09.2014 in Govt. Medical College Hospital, Jammu as Stretcher Bearer and further deployed to MCH vide no:-201 AHJ of 2014 dated:-30.09.2014,

Whereas, as per information from concerned Medical superintendent you have remained continuously absent from duties w.e.f. 05.02.2021 to till date.

Whereas you were promoted as jr. Assistant vide order no:- 31 of AHJ of 2021 dated 27.04.2021 under endorsement no:- AHJ/2021/344-352 dated:-27.04.2021 and you submitted your joining report as jr. Assistant by post but not physically as reported by Medical Superintendent Govt. Medical College Hospital Jammu vide no:- GMCH/2021-22/14068 dated:- 22.12.2021, which was not accepted and you are continuously absent from duty till date;

Whereas as reported by Medical Superintendent Govt. Medical College Jammu hospital, vide no:- GMCH/2021-22/7871 dated:- 26.08.2021, you are un authorizedly absent from duty w.e.f 05.02.2020 to till date without any information/intimation to the concerned authority. The unauthorized absence from duty warrants action in terms of Article 128 of J&k CSR, Which includes punishment of " loss of appointment".

In view of above you are directed to explain your position as to why you opt to remain absent from the office during above referred period i.e 05.02.2020 till date and why your promotion order, be not cancelled issued vide:- 31-AHJ of 2021 dated- 27.04.2021, alongwith reason of leaving the office without prior permission from the competent authority. The reply should reach to the undersigned within a period of one week, failing which it shall be presumed that you have nothing to say in this regard and action as warranted under Rules shall be initiated against you.
