In pursuance of this office Advertisement Notice No: AHJ/SRO-384/2017/5722-26 dated: 30-03-2017 and as recommended by the Selection Committee constituted in terms of SRO-384 of 2009 dated: 14-12-2009, the candidates as Annexure A (List enclosed) are hereby appointed as Jr. ECG Technician in the Pay Scale of 9300+3480000+4200 on academic arrangement basis under SRO-384 of 2009 dated: 14-12-2009 read with SRO-409 of 2013 against the available posts lying vacant in various Hospitals of this Institution. The appointment is strictly based on their merit for a period of one year extendable up to maximum of six years (One year at a time and subject to good performance and conduct) or till selection/promotion is made in accordance with the Rules of Recruitment governing these posts, whichever is earlier. The appointees are directed to report to the Principal, Government Medical College, Jammu within a period of 15 days from date of issuance of Order.

The appointment in terms of SRO-384 shall subject to the following conditions:

- a) The appointment under these rules shall not entitle the appointee to any preferential claim for regular appointment under normal process of Selection/appointment.
- b) The appointment on academic arrangement under SRO-384 of 2009 read with SRO-409 shall terminate on the attainment of 65 years of age by the appointee.
- c) The services of these appointees shall be terminable before the expiry of the tenure of appointment with one month's notice, from either side or payment of one month's salary in lieu of notice by appointing authority.
- d) The appointees shall have to execute an agreement with the Government on the prescribed form appended as Form "A" to SRO-384 of 2009.
- e) The appointee(s) shall be paid monthly salary as per the scale provided in the SRO-384 i.e pay equal to the revised basic pay which corresponds to the minimum of the pre-revised scale for the post as per SRO-93 dated: 15-04-2009 and Dearness Allowance.
- f) The appointee(s) shall not be entitled to any other additional monetary benefit, what so ever except of House Rent allowance as applicable to in service candidate carrying minimum of the pre-revised scale of the post subject to fulfillment of the conditions provided under the relevant rules in this regard.










- g) In matters of discipline and conduct, the appointees shall be governed by rules, regulations and orders in vogue in the State Civil services on the subject.
- h) Any residuary matter shall be governed by the SRO-384 dated: 14-12-2009.
- i) The appointees shall be allowed to join on production of certificate/ testimonials in original.
- i. Academic/ Technical Qualification Certificate.
  - ii. Date of Birth Certificate.
  - iii. Health Certificate from the concerned Chief Medical Officer of the District.
  - iv. Permanent Resident Certificate.
  - v. Character certificate duly issued by concerned Police Station/SHO.
  - vi. Relevant Category Certificate (if any).
- j) The appointees are directed to report to the Principal, Government Medical College, Jammu within fifteen days of the issuance of this order failing which their selection shall be deemed to have been cancelled.

The appointment order is subject to the outcome of any writ petition pending before the Hon'ble Court regarding the same.


