Whereas, the Health and Medical Education Department has issued the appointment orders in favour of the selected candidates against the posts of class-IV on the recommendations of SSB and subsequently forwarded by the GAD Vide no:- 669-JK(HME) of 2021 Dt:- 22.10.2021 & 672-JK(HME) of 2021 Dt:- 22.10.2021.

Whereas, in these orders one of the condition has been incorporated regarding submission of joining report within a period of 21 days, the details of which enumerate as under:-

“ The appointees shall submit their joining reports physically vide no:- 669-JK(HME) of 2021 Dt:- 22.10.2021 & 672-JK(HME) of 2021 Dt:- 22.10.2021 to the concerned HOD's of the organizations indicated against each with in a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled abinitio without any further notice”

Whereas, after expiry of the prescribed terms of 21 days a number of requests have been received by the Health and Medical Education Department from the candidates in whose favour the appointment orders have been issued by the Department for allowing them to join after the expiry of the prescribed terms of 21 days on various grounds.

Whereas, after expiry of the prescribed terms of 21 days and on the recommendation of Health and Medical Education Department Vide no:- HD/Coord/142/2021-02 Dt:- 30.11.2021 final notice of week's time was issued by Govt. Medical College and Associated Hospital Jammu Vide no:-

AHJ/2021/4954-4958 Dt:- 02/12/2021 and given week's time to appointee who fails to join within the stipulated terms of 21 days.

Whereas, after expiry of the week's time Health and Medical Education Department again directed and requested Vide no:- HD/Coord/142/2021-02 Dt:- 30.12.2021 to issue notice to all the appointed candidates who have not so far submitted their joining reports with the period of 21 days from the date of issuance of formal appointment orders and extension granted thereafter for a period of week's time and given them last and final opportunity to join within week's time positively from the date of issuance of notice in their favour and in case of failure of any appointee one again to join with in the stipulated period, his/her appointment shall be deemed to have been cancelled abinitio with any further notice.
