Whereas applications were invited from eligible candidates for the post of Laboratory Assistant under **SRO-384 (Now SO 364)** in GMC & Its Associated Hospitals Jammu, UT of J&K; vide advertisement notice **No. 02 dated 07-12-2018;**

Whereas following criteria had been adopted for the preparation of the merit;

- i. Prescribed Basic Qualification 20 points**
- ii. Technical Qualification 80 points**
- iii. Total Points 100 points**

Whereas, the **posts of Laboratory Assistant which were advertised under SRO 384 (Now SO 364) vide Notice No. 02 dated 17.12.2018** on Academic arrangement basis in Government Medical College & its Associated Hospital, Jammu for a period of one year or extendable up to maximum of six years

Whereas, after scrutinizing of the Laboratory Assistant forms received candidates were shortlisted on the basis of their percentage obtained in 10+2 and technical field i.e. 20 (10+2), 80 (technical) Copy of 1st short list issued vide No. AHJ/2019-20/303-05 Dated 15.01.2020..

Whereas, many objections were received in this regard. The matter regarding criteria was discussed vide letter dated 11.10.2019 between Registrar, J&K State Para Medical Council with Administrator & Personnel Officer, AHJ on 14.10.2019 wherein a decision was taken that the marks of all the years of the Diploma would be taken into consideration for the finalization of the selection list.

Whereas, In light of this decision, a notice was issued vide dated 25.10.2019 with the directions to all the candidates to submit their mark sheets pertaining to all the years of the course. After receipt of marks sheets submitted by the candidates a merit list was again issued vide date 15.01.2020 of Lab. Assistant.

Whereas, the merit list of shortlisted 250 candidates who applied for the post of Laboratory Assistant advertised vide Notice No. 02 dated 17.12.2018 has been prepared, which is placed before selection committee.

Whereas, during scrutinizing of records it has been found that application forms of below mentioned candidates who applied for the post of Laboratory Assistant are missing. The Notice issue from this office vide No. 11 AHJ of 2021 Dated 27.03.2021 and again issued vide this office No. 02 of 2021 dated 26.04.2021 regarding resubmit

their application forms strictly as per the Advertisement Notice No. 02 dated 07.12.2108 personally. Only three candidates has deposited their application forms.

Now, in view of above and as recommended by the selection committee constituted in terms of SRO 384 (Now SO 364); sanction is hereby accorded to the selection of the candidates against the post of Laboratory Assistant ; (As per Annexure- A) with the order. The selection is subject to genuineness of all academic/technical certificate viz a viz recognition of institute.

The Selection is strictly governed by the following terms and conditions of SRO-384 (now SO 364):

- a. The selection shall be on academic arrangement basis initially for a period of one year extendable up to maximum of six years (one year at a time and subject to good performance and conduct) or till the selection/promotion is made in accordance with the rules of Recruitment governing these posts, whichever is earlier.
- b. The selection on academic arrangement basis shall by itself stand terminated on the attainment of 65 years of age by the appointee.
- c. The services of these selected candidates shall be terminable before the expiry of the tenure of appointment with one month's notice by appointing authority.
- d. The selected candidate shall have to execute an agreement with the Government on the prescribed form appended as 384 (Now SO 364).
- e. The selected candidate shall be paid consolidated pay equal to the revised basic pay which corresponds to the minimum of the pre-revised scale for the post as per SRO-193 dated 24-04-2018 + dearness allowance.
- f. The selected candidate shall not be entitled to any other additional monetary benefit, what so ever except of House Rent Allowance as applicable to in-service candidate carrying minimum of the pre-revised scale of the post subject to fulfillment of the conditions provided under the relevant rules in this regard.
- g. In matter of discipline and conduct, the selected candidate shall be governed by the rules, regulations and orders in vogue in the Civil Services Rules on the subject.
- h. Any residuary matter shall be governed by the SRO-384 (Now SO 364).
- i. The selected candidates are directed to report to the Principal, Govt. Medical College Jammu within 10 days of the issuance of this order failing which their selection shall be deemed to have been cancelled.
- j. The selected candidates shall be allowed to join on production of certificates and testimonials in original.
- k. The selected candidates shall register their degree/diploma with Paramedical Council J&K within 3 months from the date of joining.
- l. The selected candidates shall bring following documents/certificates in original at the time of joining.
 - a) Academic/Technical Qualification Certificate.
 - b) Date of birth Certificate.
 - c) Health Certificate from the concerned Chief Medical Officer of the District.
 - d) Domicile Certificate issued by competent Authority.
