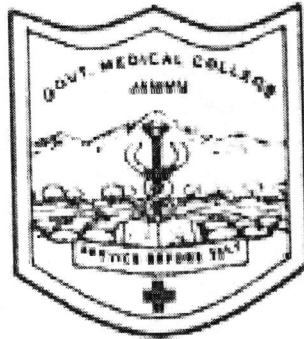

3. The bids shall be deposited from 14-12-2017 (10:00 a.m) upto 26-12-2017 (1200hrs) only.
4. The bids will be opened on 26-12-2017 (12:30 p.m.) in conference hall, Principal Govt. Medical College Jammu in presence of bidders who wish to attend or any other date convenient to the committee. In case of holiday on the date of opening of bid, bids will be opened on the next working day at the same time and venue.
5. Tender should be submitted in a single bid size envelop having two separate sealed envelops containing Technical Bid and Financial Bid. All the relevant asked documents and tender fee (in shape of DD) & earnest money (in shape of CDR/FDR) in original favouring **Principal, Govt. Medical College Jammu should be placed in Technical Bid and Discounts offered shall be placed in the Financial Bid.** The same should reach in office of **Chairman Library Committee (Prof. & Head, Department of Physiology), Govt. Medical College Jammu** through speed post/Regd. Post/Courier /by hand before due time of submission of bid alongwith other documents. Library Committee shall not be responsible for any delay due to any reason.
6. Original copy affidavit on Rs.50/- stamp paper duly attested by **1st Class Magistrate** with the effect that:-
 - a. The documents/catalogues etc enclosed with the Tender are original & genuine and have not been tampered or fabricated.
 - b. The firm has not been blacklisted in the past by any Govt./ Private institution of the country and there is no vigilance/any other investigating agency, case pending against the firm/supplier.
