## ANNEXURE "A"

### TERMS AND CONDITIONS OF HOUSE JOB

The appointments of doctors as House Officers vide Order No.SMGSHJ/HJ/2024/14274-23 dated: 28-12-2024 will be subject to the following terms and conditions for the Session January-June, 2025.

01. The appointment of doctors as Sr./Jr. House officer will be for a period of six months w.e.f. 01.01.2025 to 30.06.2025 only.
02. The Sr./Jr. House Officer shall produce following documents in original at the time of joining and submit a photocopy of the same, without which the joining will not be accepted: -
  03. 10+2 mark sheet
  04. MBBS mark sheet
  05. Internship completion certificate
  06. Registration Certificate issued by the J&K Medical Council
  07. Attempt certificate
08. The Sr./Jr. House Officer shall submit an undertaking on affidavit duly attested by the Judicial Magistrate stating:
  - that he/she has not served in any Government Department after the completion of his/her internship till date of his/her selection as Jr. House Officer in Government Medical College, Jammu.
  - that the stipend shall be released only after receiving of satisfactory CID verification report from the Police Department in favour of the candidate.
09. The House Officers will be whole time and non-practicing.
10. The House Officers will receive a consolidated stipend for the period of six months only.
11. During their tenure of 6 months, the House officer shall not be entitled to any kind of leave except the **CASUAL LEAVE for 7<sup>1/2</sup>** days only. House Officers availing excess leave during the period of house Job shall have to repeat the same in his/her own interest without remuneration stipend after obtaining proper order from office of the Principal, Government Medical College, Jammu. They shall provide sufficient valid proof for not completing the House Job during the prescribed session of House Job.
12. During their tenure as House Officer, their services shall be governed under the Rules of Conduct and Discipline, as applicable on other doctors who are member of the regular establishment.

13. The House Officers will have to pay mess establishment and such other charges as may be laid down by the Hospital Administration under the official order.
14. The services of the House Officers shall be terminated by the Principal, Govt. Medical College, Jammu, without any prior notice if they indulge in strike or any other activity which is against the interest of institution or when their work and conduct is reported to be unsatisfactory by the Head of Department /Unit or any officer, with whom they are attached. The House Officers thus terminated will have to refund stipend in one instalment, if already received by them.
15. The House Officers shall be required to stay in the College / Hospital premises, if residential accommodation is available. They shall be entitled for the accommodation including water, furniture and electricity free of charge.
16. The House Officers shall be responsible for any damage to the furniture, fittings, etc. in the hostel room/building.
17. The House Officers shall have to remain in the College/Hospital premises for 24 hours and will be available for duty at any time during the day or night. They will leave the College / Hospital premises only after obtaining the permission from the concerned Authority and shall mark their attendance on ABBAS at the time of departure and arrival in the Hospital.
18. The House Officers will not be allowed to change the specialty for which they have been selected during the period of their House Job.
19. The House Officers will not be allowed to join Junior Residents in any other Institute before they complete the House Job in GMC Jammu.
20. The House Officers will have to refund the stipend received by them in one instalment in case they leave House Job in Govt. Medical College Jammu before completion of the session.
