**Sub:** Cancellation of compassionate appointment of Suman Sharma for the post of Sanitation Worker D/o Sh.Dewan Chand under SRO 43 in place of her brother Lt. Sh. Ashwani Kumar in Government and its Associated Hospitals, Jammu.

Whereas, Lt. Sh. Ashwani Kumar working as Sanitary Worker in this institution expired on 29.12.2020.

Whereas, an application was received from Smt. Suman Sharma (sister of the deceased) as per dependent certificate issued by Assistant Commissioner (General) Jammu vide No.DCJ/Relief /2021-22/64 dated 01.09.2021 for compassionate appointment under SRO 43 and the same was forwarded to Medical Superintendent, GMCH, Jammu vide this office letter No. AHJ/SRO. 43/2021/6506-6508 dated 12.02.2022 & AHJ/SRO 43/2020-21/7341 dated 22.03.2022 with the request to examine and forward the case to this office with recommendation/remarks along with all requisite documents.

Whereas, all the relevant documents alongwith Memo under SRO 43 were received by this office from Medical Superintendent, GMCH, Jammu vide letter No. MCH/2022/1173 dated 28.04.2022.

Whereas, the case was forwarded to Administrative Department vide letter No. AHJ/SRO 43/2022/1442 dated 17.06.2022 with the request to allow this office to issue an appointment order on Compassionate Basis of the aforementioned applicant (Smt. Suman) as Sanitation Worker, Pay Level SL-1 (4440-7440+1300) in view of the notification of Minimum and Maximum Qualification for the post of Sanitation Worker as per SO 132 dated 29.03.2022.

Whereas, this office also received a Relaxation of Upper age/Qualification bar from GAD, Civil Secretariat, J&K vide OM No. GAD-SRO/96/2023(7317734) dated 03.11.2023 in favour of applicant (Smt. Suman) as Sanitation Worker.

Whereas, the case of Compassionate appointment under SRO 43 was forwarded to the concerned authority in favour of Suman Sharma D/o Lt. Sh. Dewan Chand and sister of Lt.Sh.Ashwani Kumar under SRO 43 in place of her brother issued vide this office order No. 609/AHJ/2023 dated 12.12.2023 and was deployed to Girls Hostel, GMC, Jammu vide Order No. 720/AHJ of 2024 dated 31.01.2024.


Whereas, this office vide letter No. AHJ/2024/10170 dated 13.02.2024 has sought the verification report of document academic qualification i.e. (8<sup>th</sup> Marks sheet letter) furnished by Smt. Suman Sharma & the reply was received from Zonal Education Officer, Satwari vide his letter No. ZEO/S/24-25/55 dated 24.04.2024 with the remarks that the actual report regarding 8<sup>th</sup> class



Mark Sheet of Suman Sharma D/o Late Dewan Chand received from the Headmaster, Govt. Model Middle School, Satwari, who reported that after verifying all the school records, the candidate namely Suman Sharma D/o Lt. Sh. Dewan Chand was not found in their school records.

Whereas, as per the condition mentioned in the appointment order issued by this office vide order No. 609/AHJ/2023 dated 12.12.2023 i.e. "If on verification from the concerned authorities, the qualification certificate/reserved category (wherever applicable) is found forged, false or fake, the appointee shall have no claim for appointment".

In view of the above mentioned facts, the appointment of the candidate namely Suman Sharma as Sanitation worker (SRO 43) is hereby cancelled abinito.
