

As per Advertisement Notice No. 02 of 2021 dated 26-03-2021 of J&K Service Selection Board (JKSSB), Selection list for the post of FMPHW/ANM (under Item No. 189) of Health & Medical Education Department, has been issued by the J&K Service Selection Board (JKSSB) vide letter no. JKSSB/Sel/Secy/2022-23/362-66 dated 28-02-2023 and forwarded to this office by the Administrative Department vide letter no. ME-NG/129/2023-02 dated 06-04-2023.

Therefore, consequent upon the satisfactory receipt of the CID Verification report in favour of the below mentioned candidates, sanction is hereby accorded to the temporary appointment of the following candidates, against the post of FMPHW/ANM, in the pay scale of 19900-63200, Level-2 in Govt. Medical College and its Associated Hospitals, Jammu.

The appointment of the aforementioned candidates shall be subject to the following conditions:

- 1. The appointees shall submit their joining reports to the Principal, Govt. Medical College, Jammu within a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period of time, his/her appointment shall be deemed to have been cancelled ab-initio, without any further notice.
- 2. The appointees shall be allowed to join only on the production of the following documents:
 - a) Academic Qualifiaction Certificates.
 - b) Matriculation/Date of Birth Certificate.
 - c) Health Certificate issued by the Chief Medical Officer.
 - d) Domicile Certificate issued by the Competent Authority and Character Certificate from concerned Police Station.
 - e) That if the candidate has taken loan for self-employement from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counselling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government Service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appoint

regarding both relinquishment of proprietorship and stakes, if any. In such selfemployement unit/enterprise and recovery to be made and also personally monitor it recovery.

- f) Relevant Category Certificate, wherever applicable.
- g) Character Certificate from concerned Police Station.
- h) Any other document(s) as required under rules.
- 3. Verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
- 4. The salary of the appointee(s) shall not be drawn and disbursed to them unless, satisfactory report in respect of (3) above is received in his/her favour.
- 5. The appointee(s) shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.
- 6. The interim arrangement, if any, made against the above post shall be deemed to have been terminated forthwith.
- 7. The appointment in Divisional Cadre is non transferable from one Division to another or from one Medical College to another.
- 8. The appointment of the selected candidate(s) shall further be subject to outcome of the writ petition (s), if any, pending on the subject before any Court of Competent jurisdiction.
- 9. The inter-se-seniority of the appointees shall be as per the merit secured by them in the selection process, as indicated against each in the selection list furnished by the J&K Service Selection Board.

The appointee(s) shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that:

- a) If on verification from the concerned issuing authorities, the qualification certificate/reserved category (wherever applicable) is found forged, false or fake, the appointee shall have no claim for appointment.
- b) The appointee shall abide by all the terms & conditions as laid down in their appointment order.
- c) The appointee shall be liable for action as warranted under rules for violating any of the aforementioned conditions as indicated in their appointment order.
