- The appointee shall submit his/her joining report to the Principal, Govt. Medical College, Jammu
  within a period of 21 days from the date of issuance of this order and in case of failure of
  appointee to join within the stipulated period of time, his/her appointment shall be deemed to
  have been cancelled ab-initio, without any further notice.
- 2. The appointee shall be allowed to join only on the production of the following documents:
- Academic Qualification Certificates.
- b. Matriculation/Date of Birth Certificate.
- Health Certificate issued by the Chief Medical Officer.
- d. Domicile Certificate issued by the Competent Authority.
- That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counselling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government Service He/she shall be required to repay the entire loan liability in sultable EMIs to be worked out by the DIC Concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointed regarding both relinquishment of proprietorship and stakes, if any. In such self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
