- The quoter has to submit the name of company/manufacturer on the quotation of the drugs/narcotics to be supplied alongwith the manufacturer/company certificate or authority letter of being the authorized dealer of the manufacturer/company.
- The analytical report of the drugs/narcotics should be attached with the supply and the shelf life of the drugs/narcotics should be at least one year remaining or  $\frac{3}{4}$  remaining of the total shelf life whichever is more at the time of supply.
- If the Supplier failed to supply at the quoted rates, then the undersigned reserves the right for debarring/blacklisting of firm for a period not less than 2 years.
- The undersigned reserves the right to accept or reject any quotation or a part thereof, without any reason. Any dispute, if arises, shall be subject to the Jammu jurisdiction.
