3. The appointee shall be responsible for the job assigned by the competent authority from time to time.
4. The appointee shall work directly in consultation with the Principal Investigator and the monthly work done report from concerned Principal Investigator shall be the basis of their continuation on the said job.
5. The contractual appointees shall submit his/her willingness to join within seven days from the date of issue of this order failing which their engagement as such shall be treated as cancelled without any further notice. The actual period of job will start after the expected transfer of funds will be released by the UNICEF to the competent authority.
6. These candidates on the selection(s) shall have to execute and an agreement, duly attested by the 1st class Magistrate to the effect that he/she will not leave the department before the completion of contract and also that he/she will not claim any government/permanent posts on the basis of these selection.
7. Any candidates found guilty of impersonation or submitting fabricated or tempered documents/testimonials or making incorrect/false information or suppressing material information shall render such person liable for legal action under law and his/her candidature shall be cancelled in case such a defaulter is traced after selection his/her contract shall be terminated without any information to him/her.
8. In case of any adverse report from the HOD concerned, the engagement of the applicant shall out rightly be cancelled without any notice.
